



## Application for Outdoor Gathering in Excess of 10 People

**Background:** Under Governor Greg Abbott’s Amended Executive Order GA-28, dated July 2, 2020, any outdoor gathering in the city limits in excess of 10 people is prohibited, unless approved by the mayor. Set up the event to ensure individuals not of the same household can maintain social distancing (6 ft separation).

Advise attendees to self-screen before coming to the gathering for COVID-19 signs and/or symptoms, i.e., cough, fever, sore throat, loss of taste or smell, muscle pain, headache, known close contact with a person who is lab confirmed to have COVID-19.

Advise attendees that individuals aged 65 or older are at a higher risk of COVID-19 and should stay at home as much as possible. Large gatherings, even those held outside, pose a significant risk to this population.

Make hand sanitizer, disinfecting wipes, soap and water, or similar disinfectant readily available to attendees.

Have individuals wear face coverings at the gathering when within 6 ft. of another person who is not a member of the individual’s household. Individuals may remove face coverings to consume food or drink.
