Sealed bids, in duplicate, addressed to the Honorable Mayor and City Council of Waxahachie, Texas, for: Little Creek Trail, Waxahachie, Texas prepared by Dunkin Sims Stoffels, Inc., 622 West State Street, Garland, Texas 75040 (phone number 214-553-5778), will be received at the office of **City Secretary** of the **City of Waxahachie, 401 S. Rogers Street, Waxahachie, Texas 75165** until Tuesday, October 16, 2018 at 2:00 p.m. Bids received after 2:00 p.m. on that date will be returned unopened.

The work includes: approximately 1.9 miles of eight-foot (8') wide concrete trail, associated adjacent concrete flatwork, stamped concrete pavement, concrete retaining walls, 24' x 44' pavilion, trail amenities, trail signage, drinking fountains, 8' x 12' bench shelters, earthwork, erosion control, site utilities, turf establishment, landscaping, irrigation and associated construction activities.

All bids will be opened at the City of Waxahachie, at which time a tabulation will be made for consideration of the Owner in awarding a contract. Any bids received after the closing time will be returned unopened.

The Contractor shall identify his/her bid on the outside of the envelope by writing:

Bids shall be accompanied by a cashier's check or certified check, drawn upon a national or state bank, in an amount not less than five percent (5%) of the total maximum bid price, payable without recourse to the City of Waxahachie, or a bid bond in the same amount from a reliable surety company, as a guarantee that the bidder will enter into a contract.

**Bidding Documents:** A maximum of two sets of Plans, Specifications and other Bidding Documents for this project may be obtained by General Contractors and Primary Sub-Contractors from the office of Dunkin Sims Stoffels, Inc., 622 West State Street, Garland, Texas 75040, (phone number 214-553-5778), upon receipt of a non-refundable check for \$100.00 per each set of plans, payable to the **City of Waxahachie**. Partial sets of drawings and specifications will not be available.

Although not mandatory, Bidders are strongly urged to attend this meeting. Any misunderstandings due to non-attendance will not be reason for letting a Bidder out of the bid.***

The right is reserved by the Mayor and the City Council, as the interest of the City may require, to reject any and all bids, and to waive any informality in bids received.

No officer or employee of the City of Waxahachie shall have a financial interest, direct or indirect, in any contract with the City of Waxahachie.
