## REQUIREMENTS FOR MARKET VENDOR PERMIT

The following items will need to be met to obtain a market vendor permit.

1. Application filled out and approved (attached)
2. Approval from Director of Environmental Health
3. Pay necessary fees

The following rules will need to be met or permit will be revoked.

1. It shall be unlawful for any vendor to engage in the business of peddling within the City during non-operational hours established by the Downtown Market Committee.
2. It shall be unlawful for any person to give any false or misleading information in connection with his/her application for a permit required by this article.
3. Every vendor having a permit issued under the provisions of this article and doing business within the City shall display his permit upon the request of any person and failure so to do shall be deemed a misdemeanor.
4. Vendors will only be allowed to sell agricultural items (as defined in the Waxahachie Downtown Market Rules and Regulations) under this permit. (Prepared foods are not permitted unless additional permit(s) are issued and requirements met.)
5. Fresh fruits, vegetables, or other produce displays shall be confined to the area assigned by the Market Manager and be elevated at least 12-inches above the ground. Fresh produce cannot be cut or sliced. (City Code of Ordinances, Sec. 13-19)
6. Retail sale of eggs is allowed as long as the name and location of the seller/farm is printed on the carton. The eggs must be refrigerated at 45°F or less. **NOTE: No grade claims can be made. Eggs cannot be sold wholesale.**
